IMPORTANT INFORMATION

In the event of a natural disaster Noble Creek Community Park is one of Riverside County's Fire Camp Bases and animal evacuation centers. The Park can be shut down to the public on very short notice. If you are required to leave the Park due to a sudden Park closure by the City of Beaumont or the County of Riverside authorities, you will be relocated or refunded an appropriate (depending on the time of closure) amount of your fees.

R.V. Park Rules

1. Speed limit is 5 miles per hour. Please drive slowly.
2. Camp sites are reserved in advance with payment. There is a **\$10.00 non-refundable fee** for administration costs. **Cancellations must be made 72 hours in advance to stay** or your reservation will not be refunded.
3. Maximum length of stay is fourteen (14) days you may re-register after 10 days of vacating campsite. No showers available.
4. One recreational vehicle, one non-camping vehicle and one tent allowed per site. **Do not park on any empty campsite. Vehicles will be towed away at owner's expense.**
5. RV's must be self-contained, free from leaks and in working condition.
6. Only camping supplies on camp site, (camping chairs, table, gas stove or Bar-B-Q's) no home furniture allowed.
7. Pets are allowed **on leashes only**. Please clean up after your pets. Noble Creek also has a dog park for your convince.
8. Quiet time is **10:00 p.m. - Sunrise**. As a courtesy to your fellow campers please keep noise to a minimum.
9. Check in time: 1:00 p.m. / Check out time: 12:00 p.m.
10. Fires are allowed in the designated fire rings and personal enclosed fire containers only. You need to please keep individual fire containers off the grass and all roadways. **NO FIREWORKS!!!**
11. RV's must display Parking Pass in window at all times; and park in their designated site.
12. **NO GOLF CARTS ALLOWED.**
13. All RV sites are 20' x 40'
14. **NO ALCOHOL IS PERMITTED IN THE PARK.**
15. Beaumont Cherry Valley Recreation and Park District is not responsible for any lost or stolen items. Please lock up your valuables.
